# Governing Board Members' Update

Metropolitan Educational Council: No items to report.

# Treasurer's Update

As the Educational Council is now a part of the ESC of Central Ohio, Mr. Hutchinson reported that the Educational Council Foundation has contracted with the ESCCO for fiscal services.

Mr. Hutchinson informed Board members that he plans to bring a recommendation forward in April to put an agreement in place to establish a health care consortium. This will formalize the consortium between the ESC of Central Ohio and the Council of Governments. It will also allow for other groups to join the consortium in the future.

Mr. Hutchinson reported that the ESC of Central Ohio will also be providing financial services to the Metro School beginning July 1, 2012. These financial services to STEM and charter schools will be provided through the creation of a Council of Governments financial services group.

Superintendent's Update

Dr. Anderson reported that he, along with Alan Hutchinson and Tom Goodney, met with the Licking County school districts interested in joining the ESC of Central Ohio for services. Dr. Anderson is continuing to meet with State legislators regarding funds following districts that decide to choose a different Educational Service Center.

Dr. Anderson reported that the ESCCO is currently conducting searches for the following district administrative position: Marysville Exempted Village Schools/Superintendent – London City Schools/Superintendent – Gahanna-Jefferson Public Schools/Superintendent. Mr. Al Meloy, formerly with OSBA, will be assisting the ESC with the Gahanna-Jefferson superintendent search.

Dr. Anderson informed Board members that a contract with Battelle for Kids is underway to provide STEM services. Mr. Dan Hoffman will be leading this effort.

Dr. Anderson also informed Board members that the establishment of 2 consortiums are underway regarding teacher evaluation system. The ESCCO is planning to provide services in the future to assist districts with this new evaluation system. A third consortium is also being established for digital learning to provide savings to school districts in this area.

Dr. Anderson reported that Dr. Harrison, President of Columbus State Community College, recently presented a progress report to Delaware, Franklin and Union County superintendents on the Central Ohio Education Compact, a regional strategy for college success.
