- **Update on Governor Kasich's Budget Proposal for Fiscal Year 2013-2014.**  
Mr. Hutchinson and Dr. Goodney provided the Governing Board members with an update on the ramifications of Governor Kasich's proposed budget on every Educational Service Center in the State of Ohio. The presentation included the review of current funding, proposed reductions for Fiscal Years 2014 and 2015, and the ESC governance plan that has been proposed by the State. Dr. Goodney informed board members that he will be testifying in front of the House Finance Committee on April 5, 2013.
- **ESC of Central Ohio Leadership Profile Discussion.**  
Dr. Ralph Johnson, ESC of Central Ohio Director of Leadership, facilitated a discussion with Governing Board members regarding the process for developing a profile for the new Superintendent for the ESC of Central Ohio.

Dr. Johnson reviewed the Ohio Superintendent Standards and steps for conducting a search. The discussion included identifying key characteristics and qualities, challenges the ESC is facing, stakeholder input and timing issues.
