This program will provide 3 school districts with recent college graduate volunteers who will work with third graders who are at risk of not meeting the third grade reading level requirement. These volunteers will receive one year of forgiveness on their student loans.

Dr. Anderson reported that OCALI has provided the State of Ohio with a comprehensive report and policy recommendations regarding Autism. As a result, OCALI will be assisting the State with the implementation of these recommendations.

Dr. Anderson assured board members that the ESC of Central Ohio's reporting of attendance data to the State of Ohio has been reviewed and found to be in compliance.
