**WHEREAS**, to reflect more accurately and communicate more effectively the mission of the school, a name change from Academic Acceleration Academy to the Early College Academy, a modification in the Education Plan as well as the Measurement and Assessment Plan is needed.

**WHEREAS**, the school board of directors has previously approved said changes,

**THEREFORE, BE IT RESOLVED** the Educational Service Center of Central Ohio Governing Board approves the aforementioned changes to the contract for sponsorship of the Academic Acceleration Academy.

2. Approval of the following joint resolution of the College and University Governing Boards and the School District Boards of Education to establish The Central Ohio Compact.

A JOINT RESOLUTION OF THE GOVERNING BOARDS OF CENTRAL OHIO COLLEGES AND UNIVERSITIES, PUBLIC SCHOOL DISTRICTS, CAREER AND TECHNOLOGY CENTERS, EDUCATIONAL SERVICE CENTERS, AND COMMUNITY, PRIVATE, PAROCHIAL, AND INDEPENDENT SCHOOLS ESTABLISHING THE CENTRAL OHIO COMPACT, INDICATING THEIR COMMITMENT TO A REGIONAL STRATEGY FOR EDUCATION DESIGNED TO IMPROVE COLLEGE PREPARATION AND EXPAND POSTSECONDARY PARTICIPATION, INCREASE THE ATTAINMENT OF POSTSECONDARY CREDENTIALS AND CREATE A HIGHLY SKILLED AND ADAPTIVE WORKFORCE, ESTABLISHING CENTRAL OHIO AMONG THE BEST-EDUCATED AND MOST COMPETITIVE REGIONS IN THE WORLD.

**WHEREAS**, higher education attainment has become an urgent priority in advancing an individual's lifelong success and independence, and in growing the per capita income of our region; and

**WHEREAS**, the availability of a highly prepared workforce may be the single most critical factor in the economic prosperity of every region in the global economy; and

**WHEREAS**, the Central Ohio region is home to numerous colleges and universities, public and private, providing a higher education infrastructure that is a competitive advantage on a global scale; and

**WHEREAS**, the Central Ohio region is home to successful urban, suburban, and K-12 school districts, which serve the interests of highly diverse communities and include some of the highest performing districts in the State of Ohio; and

**WHEREAS**, Central Ohio's educational assets could be deployed to create a deep pool of highly educated and skilled technicians and technologists, engineers and scientists, analysts, professionals, and managers; developers, writers, and creative professionals creating a competitive advantage for the region in economic development and diversification; and

**WHEREAS**, public funding of education must be used to maximize student, family, and taxpayer value; and

**WHEREAS**, the Central Ohio region leads the state in economic diversification and population growth, creating a statewide leadership role;

**NOW, THEREFORE, BE IT RESOLVED THAT THE PARTNERS OF THE CENTRAL OHIO COMPACT COMMIT TO THE FOLLOWING STRATEGIC PRINCIPLES:**

**Section1: Goal.** Compact partners commit to the regional goal that 60% of the citizens of Central Ohio hold a postsecondary credential by 2025,



ensuring that the region is a national leader and that its workforce is globally competitive.

**Section 2: Actions.** Compact partners commit to an intentional strategy of cooperation to:

- a. dramatically increase the number and percentage of recent high school graduates who earn a postsecondary credential, including workforce and technical certificates, associate's degrees, and bachelor's degrees, and graduate degrees;
- b. ensure better preparation of students at every level of further study with a particular emphasis of ensuring that all college-bound high school graduates are college ready;
- c. increase the number of high school graduates with credit toward a college degree or certificate;
- d. significantly increase the number of students transferring from community colleges to colleges and universities, with a recognized credential at each academic step;
- e. reduce time to a credential for students at all educational levels;
- f. employ differential strategies to increase the attainment rate of first generation college students, low income students, and students of color; and
- g. advance other measures of strategic importance to the region's educational and economic progress.

**Section 3: Adult Learners.** Compact partners will collaborate in innovative ways to remove obstacles facing adults who need postsecondary credentials to succeed in the economy, working adults who want to transition to new careers, and military veterans by opening and expanding alternative pathways to degrees and certificates and through innovative programming design and delivery;

**Section 4: Shared Services and Affordability.** Compact partners will actively seek opportunities to maintain affordability for students, families and communities by developing and executing programs and practices that contain costs without sacrificing quality and accessibility, facilitate earlier completion of degree or certificate programs, eliminate redundancy, and promote the use of shared services.

**Section 5: Data Sharing.** Partners will engage in active, detailed data sharing, acknowledging that the ability to track success at the level of the individual student will enable school districts and postsecondary institutions to improve student learning and attainment in a systematic manner and ensure public accountability.

**Section 6: Operating Parameters.** The operating plans and agreements between specific partners within the Compact will be driven by the local educational environment, the unique needs of students, and the unique mission of each academic institution. Institutional missions will not change as a result of the resolution; the diversity of our institutions will be leveraged to increase innovation and regional capacity. Proven and promising practices will be shared and collaborative action will be taken, where appropriate. All Compact members are committed to leveraging the strengths of their institutions to focus on completion with connection and to aligning their policies and practices with regional workforce and economic development priorities. The interdependent nature of the Compact will enable deeper alignment of systems, policies, and procedures, ensuring seamless and concurrent transition for students.

**Section 7: Stewardship.** While this resolution is not legally binding, it is a pledge to stewardship, not only of the public resources entrusted to each institution, but of our mission to build the Central Ohio Compact into the most productive educational partnership in the nation, fully able to significantly increase education attainment levels and support the region's economic growth strategies.

- **Governing Board Members' Update**

Eastland-Fairfield Career & Technical Schools:  
No Items to Report.

Delaware Area Career Center:

Mr. Bischoff reported that work is underway by the second committee to development a new learning process for the Career Center. Mr. Bischoff informed board members that the new superintendent evaluation process is working well at DACC.

Metropolitan Educational Council:

Dr. Anderson reported that Mark Tingley, longtime administrator at Buckeye Valley Local Schools, has been appointed Interim Superintendent to replace Jamie Grube, who will become MEC's Executive Director on October 1, 2012.

- **Treasurer's Update**

Mr. Hutchinson reported that the self-funded Workers' Compensation fund will be active in the near future providing the ESC of Central Ohio with significant yearly savings.

Mr. Hutchinson informed board members that, with the passage of the resolution at today's board meeting, the development of the healthcare consortium will move forward.

Mr. Hutchinson reported that open enrollment for employee benefits went well despite all the insurance changes implemented for the 2012-13 contract year.

Mr. Hutchinson reported that the first 2 payrolls of the school year were very challenging with the high volume of employee hires – over 1,900 substitute employees and approximately 200 ESC and COG hires. The human resource and payroll staffs are to be commended for their work processing this unprecedented number of new employees.

- **Superintendent's Update**

Dr. Anderson distributed a *School Choice Options and Blended Learning* document which outlines a timeline of school choice in Ohio and presents information on blended learning from various educational agencies and associations. This white paper was developed to keep our school districts informed.

Dr. Anderson shared a report with board members entitled, *Applying Systems Thinking to Improve Special Education in Ohio*, which the ESC co-authored with the Thomas B. Fordham Institute and The District Management Council. The report recommends initiatives to use systems thinking to provide ideas for saving money while improving services for special education students. The report has been presented to Dr. Richard Ross in Governor Kasich's office.

Dr. Anderson presented a draft document from the Ohio Educational Service Center Association which will be presented during the preparation of the next State budget. The document outlines the case for increasing the role of educational service center in education reforms in Ohio.

Dr. Anderson distributed the document that has been prepared to establish the Central Ohio Compact – a partnership comprised of school districts, adult career-technical centers, colleges and universities, and area business and civic leaders to develop a regional strategy for education designed to improve college preparation and expand postsecondary participation to increase the attainment of postsecondary credentials and create a highly skilled workforce in Central Ohio. In addition, Dr. Anderson presented a summary of the Columbus 2020 Annual Report for 2011.
