WHEREAS, it is required by law that no monies of the Educational Service Center shall be disbursed by check unless signed by the Treasurer/CFO and no purchase order shall be issued without the signatures of the Treasurer/CFO and Superintendent of the Educational Service Center of Central Ohio, and

WHEREAS, the Office of the Auditor of State through H.B. 694 has approved the use of facsimile signature by the Treasurer/CFO impressed upon each check and the signatures of the Treasurer/CFO and Superintendent impressed upon each purchase order by a machine maintained in the custody of the Governing Board Business Services Center.

7. Governing Board members are eligible to purchase benefits under the Educational Service Center of Central Ohio for calendar year 2016. *[The Treasurer/CFO distributed declaration forms to members at the Governing Board meeting.]*

- **Treasurer's Update**

Mr. Hutchinson shared with the Board and there will be two staffing changes in the Business Services Center. Charla Rose, the current Payroll Supervisor, will be moving into a new position to be responsible for data conversion and monitoring for the ESCCO's new Enterprise Resource Planning system software. Jamie Stewart, current Payroll Fiscal Specialist, will move into the Payroll Supervisor position.

In a recent discussion with the Ohio Department of Education's Fiscal Services Department, Mr. Hutchinson informed Board members that they have expressed interest in the ESCCO's auxiliary services concept.

- **Superintendent's Update**

Dr. Goodney informed Board Members that he asked Dale McVey to attend today's meeting to continue discussion and obtain feedback regarding the draft vision and mission statements discussed at last month's Board meeting. Following Mr. McVey's presentation of the latest draft of these items, Board Members recommended revisions. A new draft will be made available to Board members for review prior to the next meeting. Mr. McVey will be in attendance next month to continue discussion regarding beliefs and begin work on developing Governing Board Goals.

Dr. Goodney distributed the renewal application scoring rubric that will be used in the upcoming renewal process for two of the community schools currently sponsored by the ESCCO. Dr. Goodney also updated the Board Members on the results of the ESCCO's ODE community school sponsor evaluation and the new regulations in House Bill 2 to be incorporated in sponsorship contracts.

Dr. Goodney informed Board Members that the OESCA Executive Committee recently met. Two staff members from State Auditor Yost's office were in attendance to discuss performance audits for Educational Service Centers. Dr. Goodney provided Board Members with information regarding the proposed process being developed by the Ohio Department of Education to determine the status of high-performing ESC's.

Dr. Goodney provided the Board Members with an update on the 2016 Win-Win Agreement renewal process. He, along with Mr. McVey, have engaged with every Superintendent and Treasurer to address any questions or concerns.

- **Ohio Healthcare Consortium**

Mr. Hutchinson reported to Board Members that the Consortium's finances are very healthy and beyond funding their reserves. Mr. Hutchinson informed Board members that two school districts have recently expressed interest in joining the consortium.


