The Superintendent recommends soliciting contracts for work at the Ventures building to make it ready for use based upon an urgent necessity and waiver of competitive bidding.

Rationale:

1. The ESCCO is leasing space from the Delaware County DD and the space has serious deficiencies that must be addressed before the space can be used by ESCCO for its programs.
2. The work must begin as soon as possible in order to have it complete before the scheduled beginning date for programs at that location.
3. Costs were solicited from multiple contractors by Ohio Equities, the property manager for ESCCO, for each category of work needed.
4. Based upon the Ohio Equities review and evaluation of submitted quotes the board authorizing the following scope of work to be awarded to the recommended contractors based on experience and availability to perform the work within the current time constraints. All work to be performed shall not exceed \$100,000.

Category of Work
Painting
Carpet
Security System
Fire Alarm System
Repair Clock System
Window Repair
Lighting Repair

The Board resolves as follows:

1. The Board, based upon the authority given in ORC 3313.46, finds that an urgent necessity exists and waives competitive bidding for the work needed at the Ventures building to make it usable for ESCCO programs, which are scheduled to begin May 31, 2016. The Board finds that it is in its best interest to move forward with the work as quickly as possible based upon pricing solicited by Ohio Equities on behalf of the ESCCO so that the space will be ready as planned.
2. The Board authorizes the award of the contracts for the work to the contractors, as having submitted the lowest and best proposal for the specified work, in the total amount not to exceed \$100,000.
3. Treasurer is authorized to sign contracts for the work on behalf of the Board, to issue a purchase order for each contract, and to prepare other required documents for the work.

- **Superintendent's Update**

Dr. Goodney distributed a handout to Board members outlining a comparison between "No Child Left Behind" and "Every Student Succeeds Act" that replaced it. The ESSA will provide more State and local control and more flexibility for school districts.

Dr. Goodney reported on the passage of House Bill 390 that corrected and restored some funding previously cut to ESCs. Dr. Goodney also recommends that the ESCCO apply for "high performing" status. If achieved, the ESCCO would receive an additional \$2 per student.

Dr. Goodney reported on pending legislation requiring performance audits for ESCs. The bill has moved out of the House to the Senate side to begin discussion.

Dr. Goodney distributed a handout on the ESCCO's Social Enterprise proposal and reported on a recent event in Mayor Ginther's office to discuss the five social enterprise proposals. Mayor Ginther was very interested in the development of these cultural-competency tools for city employees. Dr. Tom Reed is currently leading this effort for the ESCCO.

Dr. Goodney provided Board members with two handouts outlining the number of functions such as resignations, new hires, substitutes, and contract

adjustments performed by ESCCO human resources and payroll staff for an entire year.

Dr. Goodney provided an update on a recent meeting he had with the CEO of Meta Solutions and the upcoming changes currently underway at that agency.

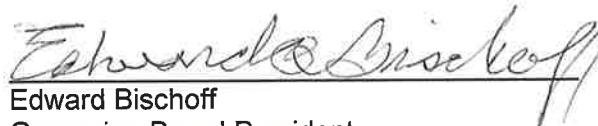
