Minimum Qualifications:

- Ohio Educator License including TESOL or Masters in TESOL or related field
- Five (5) years of teaching experience with EL students
- Experience with leadership or educational administration
- Expertise in program options, services and curricular materials that address the educational needs of EL program participants
- Deeply knowledgeable in EL topics and up to date on professional trends in the instruction of English Learners
- A record of collaboration in the professional community
- Demonstrated skill in oral and written communications.
- Ability to work with various constituencies including classroom teachers, principals, district administrators, regional service providers and Ohio Department of Education staff.
- Knowledge of adult learning theory.
- Proficient in Microsoft Word, Excel, and Power Point.
- Excellent interpersonal skills.
- Demonstrated ability to prioritize multiple assignments and meet deadlines with minimal direction.
- Reliable transportation
- Documentation of a clear criminal record in compliance with state statute
- Compiles with drug-free workplace rules and board policies

- Shares knowledge and expertise related to EL services, policies and guidelines relating to EL Identification, Ohio English Language Proficiency Assessment (OELPA), Ohio English Language Proficiency Standards (OELP)
- Works in collaboration with the Director of Literacy and Learning and other members of the Center for Achievement and Leadership
- Collaborates with the Director of Literacy and Learning and the Director of Program Resources to complete ODE's CCIP Narrative, Budgets, District Consortium information and data
- Seeks out new resources
- Evaluates instructional methodology related to Ohio learning standards for English Language Learners
- Focuses conversations with teachers and administrators on how students learn language
- Assists with the evaluation of programs and provides recommendations on curriculum, materials, and instructional pedagogy
- Customizes professional development based on district needs and wants
- Assists in the evaluation of student learning data, utilizing the data support staff within our agency
- Supports the marketing and services of "On Demand Interpreters to districts"
- Works effectively with other Agency staff to support the work with districts and schools
- Performs other specific job-related duties as assigned by superintendent or his/her designee
