Governing Board Members' Update

Eastland-Fairfield Career & Technical Schools

Mr. Lopez and Mrs. Galbraith reported that the graduation ceremonies at both locations were very well organized this year. Eight sessions were held throughout the day by program. The program for adult students will be held next week. Mrs. Galbraith also reported that a presentation at last week's EFCTS Board meeting by students working at an MRDD program was very impressive.

Delaware Area Career Center

Ms. Kish reported that she has reached out to the DACC Superintendent, Mr. Poroda, to bring her up to date on DACC matters to ensure the smooth transition for her joining their Board of Education on January 1, 2023.

Treasurer's Update

Mr. Varda reported that all of the audits have been completed and will be publicly released in June. He also reported that there were no single audit findings. The Board members will be receiving an email next week that will include a copy of the audit.

Ohio Healthcare Consortium Update

Mr. Varda informed Board members that an overview of health benefits took place at last week's Consortium Board meeting. He reported that the use of Marathon continues to increase and feedback from staff members who have used this service is very positive. Marathon is working to try to find a northern location to serve staff in northern Franklin County and Delaware County.

Superintendent's Update

Mr. Marsh informed Board members that the ESC of Central Ohio just received notification that we have been awarded two new grants to partner with the Ohio Educational Service Center Association (OESCA) and the Ohio Department of Education (ODE). This is the first time ODE has partnered with OESCA as it is looking to ESC's to deliver services for ODE initiatives. The first grant in the amount of \$10.5 million will be used to train trainers, school districts and teachers the process to use to select high quality instructional materials.

The second grant in the amount of \$3 million dollars will be work in the area of Mathematics pathways. The work will entail the development of alternatives to Algebra II.

New ESCCO staff will be hired in both the Center for Achievement and Leadership Services and in the Center for Business Services to take on this large undertaking of both grants.

Mr. Marsh also informed Board members that Sophie Speelman, Coordinator for Community Schools, does an outstanding job with the compliance rules set for community schools in Ohio. She took the initiative recently and met with Senator Brenner, Chair of the Senate Education Committee, to discuss the abolishment of the Zero Business rule that has caused the ESCCO to be rated ineffective for the 2018-2019 school year and thus in an intensive evaluation cycle each year. Senator Brenner was very receptive during the meeting.

Mr. Marsh reported that a contract was signed last week to begin construction at the new buildings that will house staff and Ventures Academy. The building that will house office staff is projected to be complete before June 30th and the building housing the Academy by July 31st.
