Governing Board Members' Update

Eastland-Fairfield Career & Technical Schools

Mrs. Galbraith reported on an excellent presentation by students in the Bio
Science program at the last EFCTS Board meeting. Mrs. Galbraith also
informed Board members that the Career Center now has a retention rate of
80% of its students.

Delaware Area Career Center

Ms. Kish informed Board members that she attended the last DACC Board meeting that included discussions on the Center's parking lot project and wetland credits. Ms. Kish reported that the enrollment in after school programs at the Center has increased dramatically. Ms. Kish has a meeting scheduled with the Superintendent next month to discuss current issues before joining the DACC Board in January.,

Treasurer's Update

Mr. Varda distributed and reviewed a handout outlining the funds awarded to the ESC of Central Ohio for the GEER, ESSER and CARES Act Federal grants from Fiscal Year 2021 through Fiscal Year 2024 to benefit client school districts. In response to Mrs. Glitt question, Mr. Varda provided information on indirect cost rates as they relate to these particular grants.

Ohio Healthcare Consortium Update

Mr. Varda provided the Board members with information regarding the decision of the Consortium Board to increase health insurance rates effective January 1, 2023. The dental insurance rates will remain the same for 2023.

Superintendent's Update

Dr. Goodney informed Board members that Debra Ray and Elaine Organ have assisted Craig Burford, Executive Director of the Ohio ESC Association, with document preparation for the 2022 Connect and Collaborative conference scheduled next week and will also be attendance to assist the over 200 attendees.

Dr. Goodney reported that Dr. Dan Good is serving as the Reynoldsburg City Schools Interim Superintendent. The Reynoldsburg Board of Education plans to begin a search very soon and is in the process of selecting a firm or agency to conduct it. The ESC of Central Ohio will offer search services for their consideration.

Dr. Goodney provided an update on the key findings of recent focus groups conducted by our marketing consultants from Adept for Worthington Industries to identify common factors that lead high school students to enter the workforce full-time over going to college or working part-time; why individuals choose to enter the manufacturing industry over other equally viable options; common timelines and processes that students undertake to make this decision and move forward and what employers and schools can do and when to better support, motivate and attract this population. Forty-six individuals took part in the focus groups between the ages of 18 – 24. Additional focus groups are being planned.

In addition, Dr. Goodney provided an overview of the results of a pilot survey of 55 graduates conducted by the Graduation Alliance in partnership with Dublin City Schools and the ESC of Central Ohio to learn about their current employment status and goals. The purpose of the survey was to determine where graduates are and what they are doing in the areas of employment and continued education. Plans are underway to conduct surveys for 8 to 10 of our client school districts.
