- Governing Board Members' Update:
  - o Eastland-Fairfield Career & Technical Schools (EFCTS)-Mr. Alcock
    - Negotiations with the newly formed Collective Bargaining Unit continue
      - The Governing Board or EFCTS rejected the fact finder report and issued a last best offer to the union
      - The Governing Board and Administration is anticipating a strike vote by the union
  - Delaware Area Career Center (DACC)-Ms. Kish
    - Fanning Howey partnering with DACC on curriculum needs for workforce opportunities for students
      - Advocating a separate curriculum for construction industry trades
- Ohio Health Consortium
  - CFO/Treasurer Varda updated the Governing Board on the renewal of the stop loss coverage for the Ohio Health Plan (OHP). The plan renewed with the current carrier at an increased premium that was less than budgeted after receiving quotes from other carriers. The Governing Board of OHP considered increasing the stop loss threshold but the savings in premium costs did not exceed the estimated financial exposure tot the plan.
  - Dr. Goodney updated the Governing Board on his work with newly approved legal firm to review the health care model we currently have with the goal of determining the best model for the ESCCO in the future.

Superintendent's Update

- Dr. Goodney distributed to the Governing Board Members a summary of legislative action during the recently concluded "lame duck" legislative session.
- Dr. Goodney discussed his continued work with Corporate and Community Foundations to pursue grants and/or contracts that fund services and/or programs to support our member districts and other stakeholders.
- Dr. Goodney announced that the Board of Education of the Jonathan Alder Local School District on the recommendation of their superintendent approved a resolution to align with the ESC of Central Ohio. The Governing Board will be asked to approve a comprehensive contract with Jonathan Alder Local Schools and London City Schools, whose action to align Dr. Goodney announced at the November meeting, in the spring of 2025 and the districts will be officially aligned with the ESCCO on July 1, 2025.
