Community Schools Update

Mr. Trego informed Board members that all six community schools sponsored by the ESC of Central Ohio are up for renewal and have submitted an application this past Fall for continued sponsorship. In addition, The Graham Schools are asking for approval of a preliminary agreement to give them the opportunity to apply for Federal funding to open a new middle school. The applications have been reviewed both internally and externally. Ms. Speelman and Ms. Trusley

provided Board members with the results of these reviews for each school. The reviewers came to consensus and made evidence-based recommendations based on academic and non-academic measures. Community school sponsors are required to rate each school in the areas of academics, finance and organization. In addition, the Board members were presented with the new school application rubric table for the preliminary agreement request for the new Charles Middle School.

Mr. Bischoff asked if the community schools sponsored by the ESCCO are meeting the academic needs of their students. Mr. Trego informed Board members that academics are the real focus and all six schools have taken this seriously. The State Support Team/Region 11 is working with the schools to implement appropriate plans to provide support in academic areas. Mr. Bischoff also asked if students were being tracked after graduation to see if the education they are receiving made them productive adults. This would be the responsibility of the community school if they chose to do this type of tracking

Mr. Spencer asked if the ESCCO should be concerned with those schools with fiscal issues. Mr. Varda shared that the financial numbers are more stable than they appear in the rubric table. Funding is based on attendance which is tracked by the schools. Mr. Spencer also asked if the Board should be concerned about adding another school. Mr. Trego informed that the administration is comfortable with recommending this preliminary approval for Graham Middle School as it will only open if Federal grant money is obtained. The ESCCO will monitor and provide support as the new school begins to form.

Recommendations to approve the renewal of sponsorship contracts will be presented to Board members this Spring.

Mr. Tom Shafer, Superintendent of The Maritime Academy of Toledo, was in attendance and commended the ESCCO community school coordinators for their hard work and thanked Governing Board members for their continued support.
