## **EPSEA LEAD EDUCATIONAL LIAISON**

### **Minimum Qualifications:**

- Bachelor's degree required
- Bachelor's degree in Education or Social Work recommended.
- Three or more years of successful experience in an educational or child services setting required; child protection casework, teaching, school leadership, counseling, or mentoring preferred.
- Excellent communication and documentation skills required.
- Candidate must be proficient with using Office 365.
- Experience working with foster youth or the child welfare system preferred.
- Understanding of Every Student Succeeds Act (ESSA) as it relates to school settings, educational rights and requirements of foster children/system engaged youth, and processes for academic support preferred.
- Demonstrated ability to form positive, supportive relationships with school district personnel.
- Documentation of a clear criminal record in compliance with state statue
- Complies with drug-free workplace rules and Board policy

*Note:* This assignment may require a valid driver's license and access/availability of a reliable vehicle. Employees must meet all prerequisite and ongoing qualifications to be covered by the service center's insurance carrier.

### **Job Objectives:**

In this position, the Lead Educational Liaison will work to build relationships with youth referred by Franklin county Children Services, school personnel, foster parents, kinship providers, and FCCS caseworkers to support the academic success of youth in custody of FCCS. Liaison will complete weekly and monthly SACWIS reports. Liaison will also participate in the Partnership for Success SEL Collaborative.

#### **Responsibilities and Essential Functions:**

"The following duties are representative of performance expectations: however, the list below is not ranked in order of importance."

Encourages student development of academic, attendance, and behavioral goals. Provide day to day management of the ESSA process including:

- Notification of district and school within ESSA parameter (one day).
- Leads collaboration with school on Best Interest Determination within ESSA parameter (within five school days of placement).
- If it is determined that the best interest of the child is to remain in the school of origin, will collaborate with school district to develop a implementation plan for transportation and funding within the ESSA parameter (within five school days from best interest being determined).
- Coordinating interim transportation until permanent transportation has been resolved.
- Serve as the Single Point of Contact for education related issues related to ESSA and/or EPSEA with FCCS Staff, ESCCO Staff, or our partnering school districts or agencies.
- Coordinates the transition process for students entering or leaving the program.
- Serves as a referral/resource agent for caseworkers, foster parents, and others involved in the educational success of referred youth.
- Must possess excellent written and verbal communication and interpersonal skills.
- Acts as a liaison between school district, FCCS or provider staff and guardians.
- Provides appropriate and timely feedback regarding student progress.
- Maintains current knowledge of the program and protocol (policy and procedures) and guidelines.
- Completes documentation for the transition process for each student/patient and keeps accurate schoolwork records, reports to FCCS, etc.
- Understands the importance of the whole student, both academically and social emotionally and provides appropriate supports.
- Participates in the Partnership for Success Social Emotional Collaborative.
- Tracks time and miles using Office 365 Calendar and Monthly Mileage log
- Performs other specific job-related duties as directed by the Superintendent or his/her designee

"Job performance is evaluated according to the policy provisions adopted by the Governing Board of the Educational Service Center of Central Ohio."

#### **Conduct:**

Each staff member shall remain free of any alcohol or non-prescribed controlled substance and abuse of any prescribed controlled substance in the workplace throughout his/her employment with the ESC.
