A RESOLUTION AUTHORIZING THE PAY OF WORTHINGTON CHRISTIAN INTERVENTION SPECIALIST

WHEREAS, previously only nonreligious schools could receive auxiliary service funds directly from the Ohio Department of Education, while religious schools had to receive funding through a local public school district; and

WHEREAS, pursuant to HB 110 of the 134th General Assembly, all chartered non-public schools can now receive auxiliary service funds directly from the Ohio Department of Education instead of through the local public school district; and

WHEREAS, Worthington Christian School previously received auxiliary service funds through Worthington City Schools; and

WHEREAS, Worthington Christian School now receives funds directly from the Ohio Department of Education; and

WHEREAS, Intervention Specialist Molly Kremnitzer provides services to Worthington Christian School but has been paid through Worthington City Schools for the 2021-2022 school year because of the previous requirement that auxiliary service funds run through a local school district which meant that Worthington Christian School reimbursed Worthington City Schools for Ms. Kremnitzer's services; and

WHEREAS, Ms. Kremnitzer, having been paid through Worthington City Schools, has been paid pursuant to Worthington City Schools' salary schedule; and

WHEREAS, Worthington Christian School desires to continue to employ Ms. Kremnitzer and Ms. Kremnitzer desires to continue her work with Worthington Christian School; and

WHEREAS, beginning the 2022-2023 school year, Ms. Kremnitzer can no longer be paid through Worthington City Schools due to Worthington Christian School's receipt of its auxiliary service funds directly from the Ohio Department of Education; and

WHEREAS, the ESC of Central Ohio Council of Governments desires to assist its Member District Worthington City Schools by employing Intervention Specialist Kremnitzer, so that she can continue to provide services to Worthington Christian School; and

WHEREAS, the salary schedule the ESC of Central Ohio Council of Governments pays less than Worthington City Schools; and

WHEREAS, the ESC of Central Ohio Council of Governments and Worthington Christian School desire to pay Ms. Kremnitzer a salary for the 2022-2023 school year that does not result in a pay cut for Ms. Kremnitzer; and

WHEREAS, the only way to ensure that Ms. Kremnitzer avoids a pay cut for the 2022-2023 school year is to place her on Step 15 of the ESC of Central Ohio Council of Governments salary schedule despite the fact that she only has nine (9) years of service; and

WHEREAS, this Resolution is necessary to ensure that a qualified individual with experience can continue to serve Worthington Christian School without suffering a pay cut through no fault of her own.
