- Bachelor's degree in related fields, or comparable experience, required
- Solid understanding of Object-Oriented Design
- Considerable experience with PHP, Git and MySQL
- Familiarity with Laravel framework
- Experience using Bootstrap or a similar CSS framework, as well as Sass
- Striving for and succeeding with simple, clean, standards-compliant, well-tested code
- Successful experience interacting professionally with clients
- Ability to explain technical concepts to people without a technical background
- Experience developing RESTful APIs
- Experience with modern front-end frameworks such as VueJS, Angular, or React, etc.
- Demonstrated ability to manage multiple and overlapping projects and priorities
- Successful experience working with, and being a part of a team
- Familiarity with TTD, testing, and PHP Unit
- Basic server administration experience
- Successful experience with mobile app development and deployment
- Successful experience with, and focus on, accessibility and web standards
- Familiarity with Apple products and tools
- Documentation of a clear criminal record in compliance with state statute
- Complies with drug-free workplace rules and Board policies

**Responsibilities and Essential Functions:**

- Working on OCALI web development projects including e-learning systems, content management systems, and survey and assessment systems.
- Collaborates on projects and their progress with the web development team
- Demonstrates accuracy, responsiveness and excellent communications with other members of the web development team and related staff
- Completes other duties as assigned by the Lead Web Developer and/or the assistant or executive director
- In addition, performs other specific job-related duties as directed by the Superintendent or his/her designee
